Subject: - Cleaner public transport services (buses) in NCR.

Sir,

Commission for Air Quality Management in National Capital Region and Adjoining Areas has been reviewing air pollution load due to vehicles in the entire NCR region, particularly during the Winter season. After detailed discussion and deliberation CAQM issued an Advisory vide Serial Number 10 of the Circular with respect to efficient and cleaner public transport services (buses) particularly the intercity and intra – city bus services within NCR to help abate Air Pollution which is as under:-

- W.e.f. 01.11.2023, all buses originated from NCR Districts in the respective States and plying to Delhi will be either Electric Vehicles or CNG or BS-VI Diesel.
- Plan and target to achieve that all buses originating or terminating in NCR to operate only on CNG/Electric Vehicle Mode by 30.06.2026.
- 3. Plan and target substantial number of buses originating or terminating in NCR will operate only on Electric Vehicle Mode by 30.06.2028.

It has also been emphasized in Advisory Number 10 that respective agencies/departments in the NCR, State Governments and GNCT of Delhi to strive to achieve the mile stones as per the action plans and takes steps for implementation accordingly.

Therefore, in order to implement the Advisory Number 10, the undersigned is hereby conveyed the directions of the Pr. Secretary-cum-Commissioner (Transport), GNCT of Delhi that the Advisory of the CAQM may be implemented in toto. No request of relaxation from the above advisory will be entertained and action as deemed fit against the defaulting vehicles will be initiated within the provisions of Motor Vehicles Act and Rules framed thereunder.
